The Junior Membership INCLUDES THE FOLLOWING:

- Free golf after 1pm, 7 days a week (walking only). Juniors may ride in a golf cart if playing with a paying adult. Parents may pay the cart fee and drive their kid around.
- ➤ Unlimited range balls during normal business hours and based on availability.
- Member guest rates for underage guests and adults.
- > 20% off select merchandise for entire family. Hard goods not included.
- > Participation in a biannual qualifier.
 - a. Those who can break 55 on 9 holes from the front tees(qualifying will occur at each course)
 - i. Qualifiers will be issued vouchers to play before 1PM. Qualifiers will be allowed one voucher a month to play before 1pm

Additional etiquette and guidelines:

- > Stay continually aware of play behind them allowing faster players to play thru during their round
- > Junior members under the age of 12 must be accompanied by an adult to access the golf course for play
- > ALL Junior Members will have full access to the range 7 days a week.
 - b. Range balls will be available in golf shop
- Mandatory Annual Orientation meeting will occur at Wolf Run Golf Club. Date and Time to be determined.
- Must complete 10 rounds of golf in a year to qualify for membership the next year
 - c. If Member does not meet 10 rounds their membership may be forfeited and awarded to individuals on waiting list
- > Each player entering golf course for play must have their own set of clubs
- > Appropriate attire is required when using facilities
- > Tennis or golf shoes required to use putting greens
- > Each membership will be set up with a charge account
- > NO range balls shall be taken to course for play
- > Monthly etiquette training will be provided at each facility to prepare the Juniors for play on course
 - d. Each member MUST pass etiquette test prior to entering course for play
- ➤ Ability to book tee times 14 days in advance
